ACTION LOG - KIDSGROVE TOWN DEAL BOARD MEETING ANNEX

Board members' initial thoughts regarding the content of a Town Deal for Kidsgrove (NB: not verbatim)

- Useful to extend the area beyond Kidsgrove town centre so that other opportunities can be included
- Important to encompass other areas opportunity to do things that are not costly but create goodwill. This is our best opportunity to improve rail and other forms of transport to provide cohesive, sustainable links
- With or without HS2, the transport links are important. A possible A50 arc is being considered to cope with growth.
- Need a submission that will catch the government's eye. Shovel ready projects, e.g. the sports centre should be looked upon favourably because it ticks a lot of boxes.
- Network Rail improvements to station are vital.
- SCC looking at sites for potential development e.g. Post office, Job Centre, etc which would open up the town to make resources, like the station and canal, more visible.
- Essential services on the high street will help to revitalise it.
- Need something drastic if we are really going to make a difference, e.g. road layout changes.
- Chatterley Valley would be a big win potential to be a real diffentiator.
- There were plans to develop the station as a community space but funding fell through. Canal not accessible to anyone with a disability. Need to manage local expectation. Essential that the Board presents a united front.
- Chatterley Valley is part of the Enterprise Zone. How does the Town Deal tie in with other activities?
- Match funding is needed to support the Town Deal but must ensure we do not double count outputs.
- Early wins are needed. What is the USP for the Kidsgrove Town Deal to make it stand out? Need to consider other ways of increasing the value of the £25m, e.g. Tax Increment Financing.
- These suggestions really align with outcomes for the NHS. There are 5 practices in the area which are developing services to promote the health agenda.
- We need to be bold because no one organisation has the ability to make the necessary step change. The station is a key asset. The entrance must be improved. Look to Alsager as a comparator.
- The 0-19 agenda is very important, need to consider what facilities are lacking around schools. Need clarity over time frame as we do not want to duplicate.
- Let's go early if we can. Do we know where the money is coming from so we can tailor proposals accordingly.
- Need to keep local voluntary and community sectors enthused.
- The rail links and local heritage make this a potentially very attractive area to encourage developers.
- Housing growth important.
- We seem to be concentrating on the town centre but there are lots of green spaces that need work to make the most of them.
- Creative People and Places funding will be available over the next three years to encourage arts and cultural development.
- Sounds like we are talking about a hub and spoke model with Kidsgrove town centre as the hub.
- Sub-groups/Task and Finish groups can be used to look at specific issues.
- Are there any particular industries we're looking at for Talke and Chatterley Valley?
- Higher quality jobs needed.
- The Local Industrial Strategy covers wide ranging sectors for Staffordshire but emphasis is on higher skills and getting young people ready to take up the higher quality jobs.
