## Re: Response to the Newcastle-under-Lyme District Borough Council final draft Local Plan 2020-2040 Matter 9 (at Regulation 19 stage)

I write as the Member of Parliament for Newcastle-under-Lyme following engagement with residents from right across the community on these issues. This is my formal submission – and response - to **Matter 9** of the final draft Local Plan from Newcastle-under-Lyme District Borough Council.

During the last two years, many individual residents and community groups have raised concerns with me on issues relating to the initial draft of the Local Plan and other areas that naturally sit under the purview of the Local Plan. I have addressed a number of the concerns outlined to me relating to Matter 9 – Employment Policies and Allocations - below. I trust that you will use the legal requirement and duty to cooperate (introduced under the Localism Act 2011) to work collaboratively – and effectively - with neighbouring local authorities and other relevant bodies and stakeholders to address the range of community and strategic needs right across Newcastle-under-Lyme.

## **Matter 9 Employment Policies and Allocations**

*Issue 9 – Are the provisions of the Plan in relation to the provision of employment land justified and consistent with national policy? Would the allocations be developable, deliverable and otherwise soundly based?* 

### **Employment land**

The need for economic growth is the key to the prosperity of our community and all those who live, learn and work here. That goes for the regeneration and diversification of our town centre or indeed, and importantly, improving job opportunities in our rural communities.

Newcastle-under-Lyme has a long and rich industrial heritage, particularly in ceramics, manufacturing, and logistics. This history has cultivated a skilled workforce that can readily adapt to new industries such as advanced manufacturing, logistics, and digital services.

I want to work with the Council to identify areas of emerging markets to bring the job creation to our community. Regrettably the current strategy appears to be solely focused on the warehouse and distribution sector – with its focus on green belt land in Audley.


