

## Newcastle-under-Lyme Local Plan Examination

Action Point 12 – what is the Council's estimate as to how much affordable housing the Plan will deliver through Local Plan allocations.

## Introduction

- This note is provided in response to the Inspector's query regarding the Council's estimate as to how much affordable housing the Plan will deliver through Local Plan allocations. This was discussed in Matter 4 (Housing Requirement) on Thursday 22 May 2025.
- 2. The Council has reviewed the site allocations proposed in the Local Plan and has prepared table 1 (below). This includes an assessment of the location of the site (in which proposed value area) and provides a corresponding view on the level of affordable housing expected to be delivered through allocations alone. Table 1 also includes an assessment of current planning approvals on relevant draft allocation sites and the corresponding amount of affordable housing expected to be provided. It is anticipated that 1,434 new affordable homes would be provided for by allocations in the Local Plan.
